- Subject to the settlement of the purchase price (including preliminary deposit, further deposit, part payment(s) and balance of Purchase Price) in accordance with the agreement for sale and purchase, the Purchaser shall be eligible for the Stamp Duty Express (“Stamp Duty Express”). The Stamp Duty Express will be applied by the Vendor directly for payment (or part payment) of the ad valorem stamp duty chargeable on the agreement for sale and purchase ("AVD") on behalf of the Purchaser. In case of dispute, the Vendor has the right to determine the amount of the Buyer's Stamp Duty Cash Rebate, and such determination shall be final and binding on the Purchaser.
